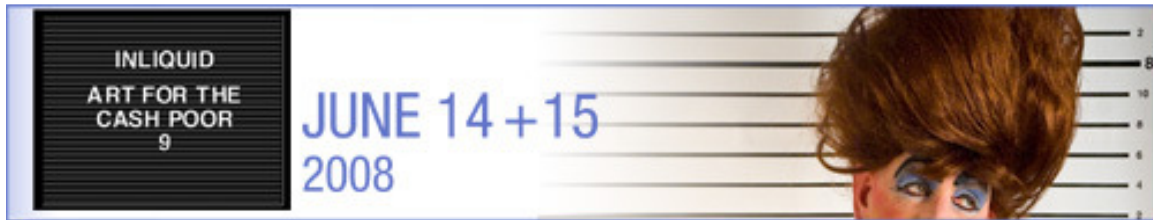

The band line-up for Sunday is : Wolfgang Rebellion, Jailbird Thunderheart, IRON, and Witchtrialz. On both days, DJs Brownske & Doctor Tommy Thunder will provide spinning action between the performances. Browsers can count on sophisticated sustenance with a wide selection of food
